## SITE HISTORY

---

The subject site was zoned B-1, Buffer Business District, but was rezoned to R-1, Single-Family Residential by the City of Mobile in 1984 as part of the Government Street Zoning Study.

The subject site was granted a Use Variance on November 6, 2023 with an extension granted on May 6, 2024, to allow a social club in an R-1, Single-Family Residential Urban District.

### Traffic Engineering Comments:

### Urban Forestry Comments:

Property to be developed in compliance with state and local laws that pertain to tree preservation and protection on both city and private properties [Act 929 of the 1961 Regular Session of the Alabama Legislature (Acts 1961, p. 1487), as amended, and City Code Chapters 57 and 65]. Private removal of trees in the right-of-way will require approval of the Mobile Tree Commission. Removal of heritage trees from undeveloped residential sites, developed residential sites in historic districts, and all commercial sites will require a tree removal permit.

### Fire Department Comments:

All projects within the City Limits of Mobile shall comply with the requirements of the City of Mobile Fire Code Ordinance (2021 International Fire Code). Fire apparatus access is required to be within 150' of all non-sprinklered commercial buildings and within 300' of all sprinklered commercial buildings. Fire water supply for all commercial buildings will be required to meet the guidance of Appendices B and C of the 2021 International Fire Code. The minimum requirement for fire hydrants is to be within 400' of non-sprinkled commercial buildings, within 600' of sprinkled commercial buildings, and within 100' of fire department connections (FDC) for both standpipes and sprinkler systems.

### Planning Comments:

The applicant is requesting a six (6)-month extension of the most recent approval of the use variance approved by the Board at its May 6, 2024 meeting with the following conditions:

- 1) Confirmation from the applicant that the facility and its services are available to members only;
- 2) Provision of compliant 24-foot wide access to the parking lot;
- 3) Provision of a compliant photometric site plan at the time of permitting;
- 4) Revision of the site plan to either include a compliant dumpster or include a note stating that curbside pickup will be utilized;
- 5) Revision of the site plan to depict a compliant residential buffer along the West property line;
- 6) Revision of the site plan to include landscape area and tree planting calculations for the site;

- 7) Obtain a Certificate of Appropriateness for all exterior improvements to the site, including signage, prior to permitting; and
- 8) Obtain all applicable permits to upgrade the property for non-residential use.

This is the second extension of this approval. The applicant states that they are requesting an extension to secure funding. To date, no permits or licenses have been requested or issued for this site.

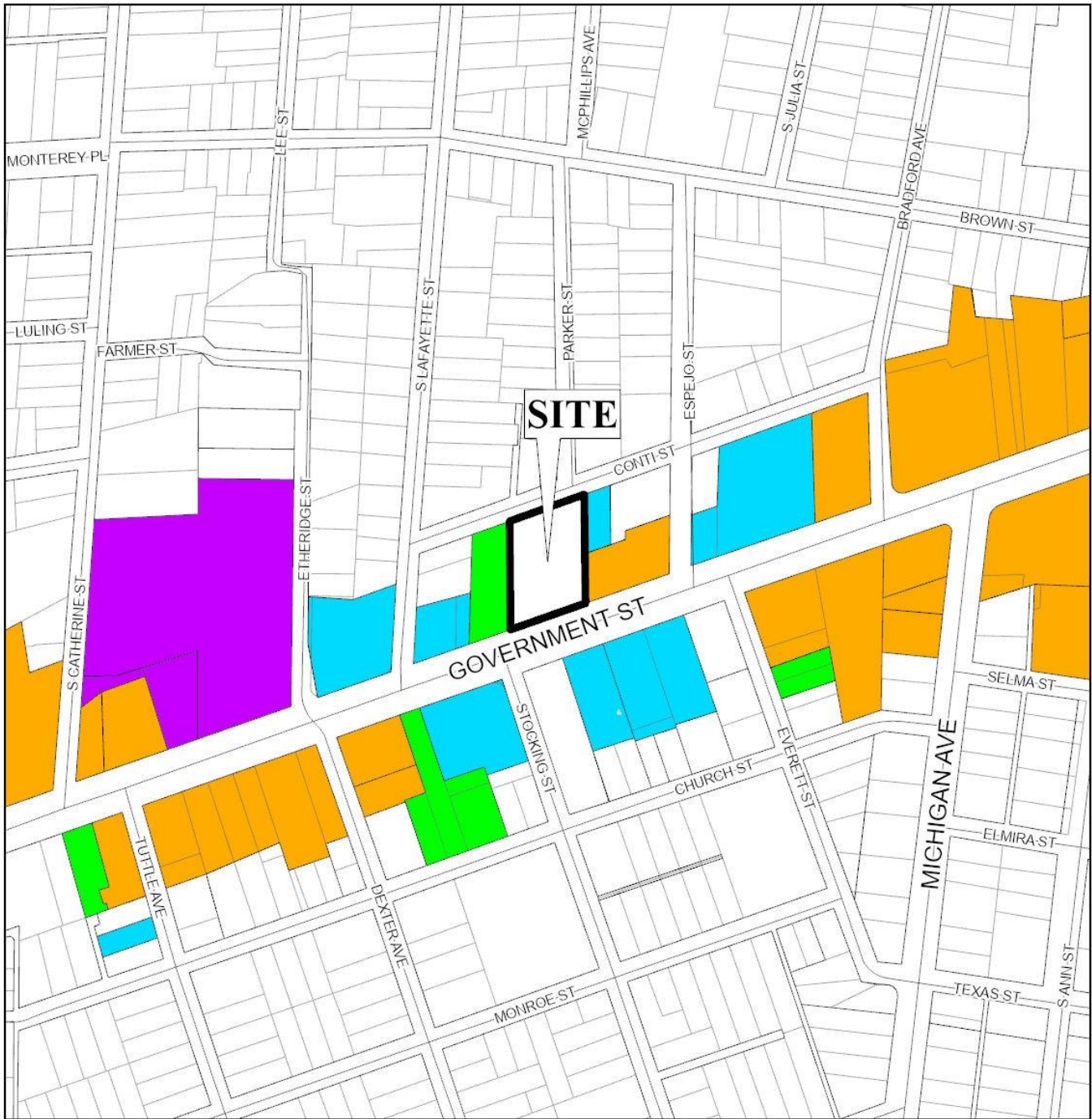

### Standards of Review:

If the Board should consider this extension for approval, it should be subject to the following conditions:

- 1) All necessary business licenses and permits must be obtained before any operations can begin at this location;
- 2) Confirmation from the applicant that the facility and its services are available to members only;
- 3) Provision of compliant 24-foot wide access to the parking lot;
- 4) Provision of a compliant photometric site plan at the time of permitting;
- 5) Revision of the site plan to either include a compliant dumpster or include a note stating that curbside pickup will be utilized;
- 6) Revision of the site plan to depict a compliant residential buffer along the West property line;
- 7) Revision of the site plan to include landscape area and tree planting calculations for the site;
- 8) Obtain a Certificate of Appropriateness for all exterior improvements to the site, including signage, prior to permitting; and
- 9) Obtain all applicable permits to upgrade the property for non-residential use.

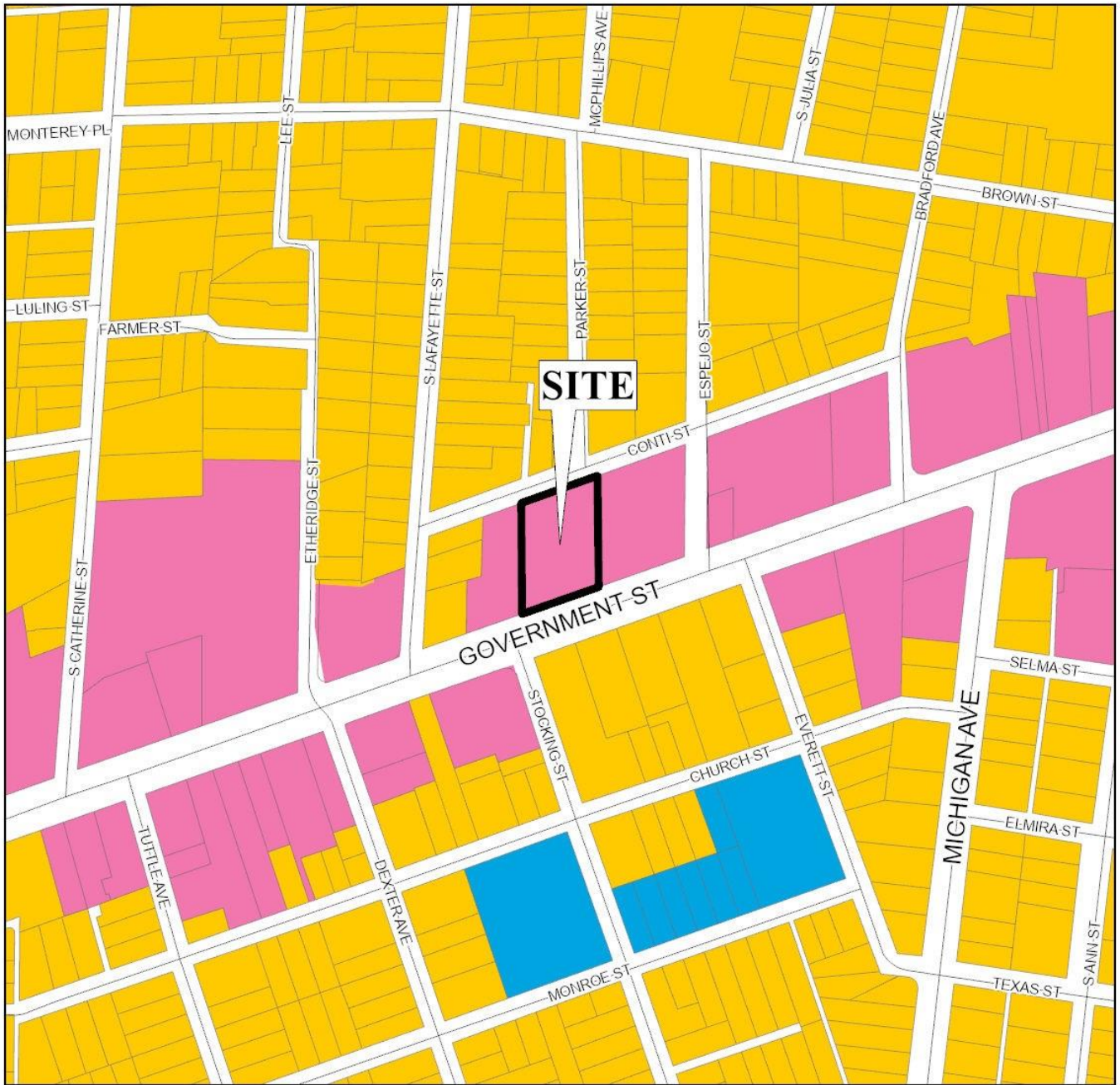

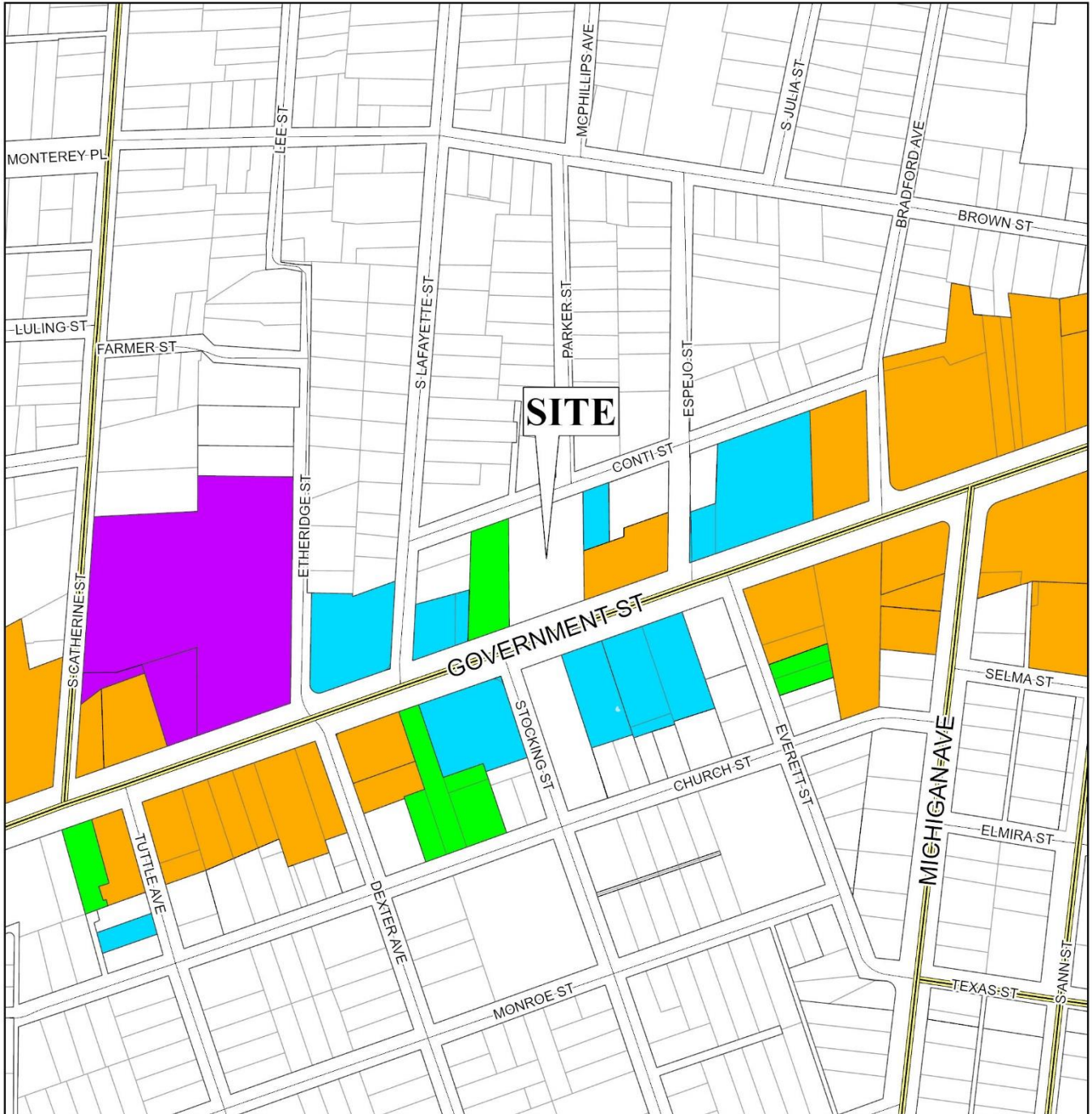

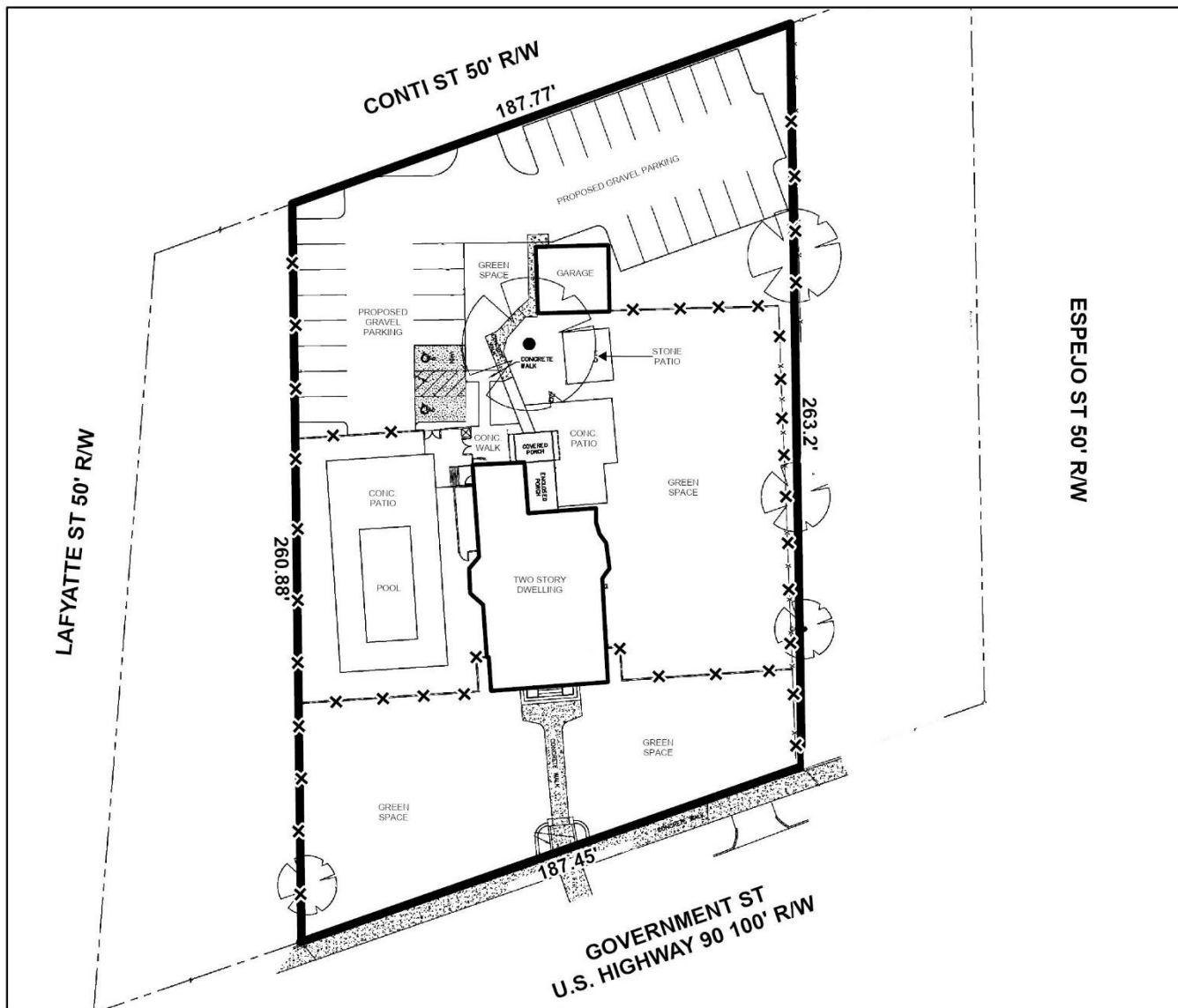

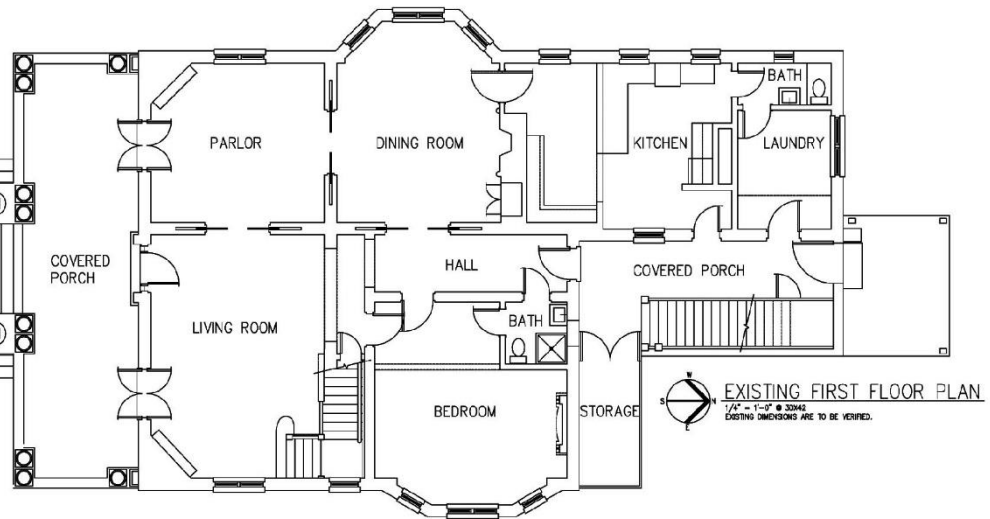
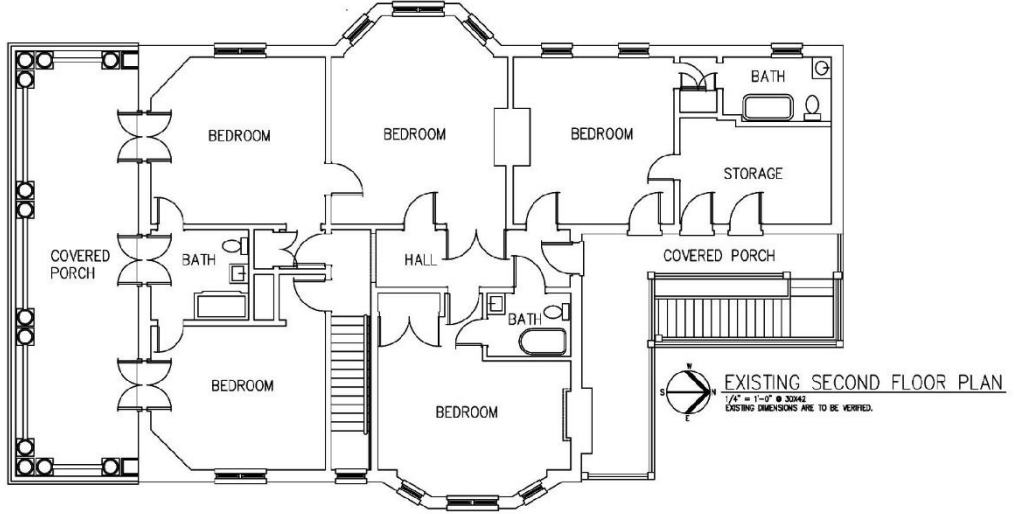

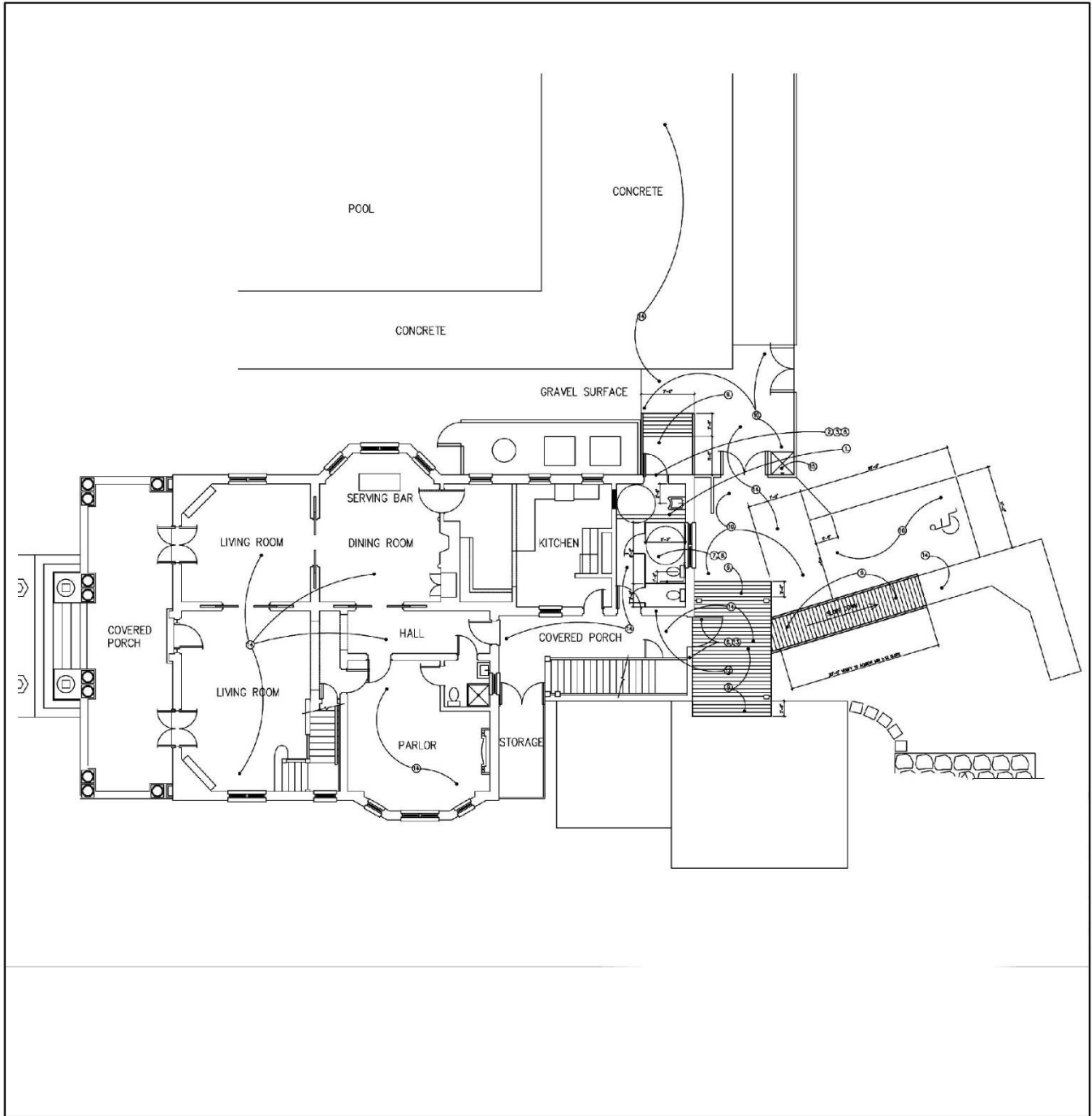

# PROPOSED FIRST FLOOR PLAN



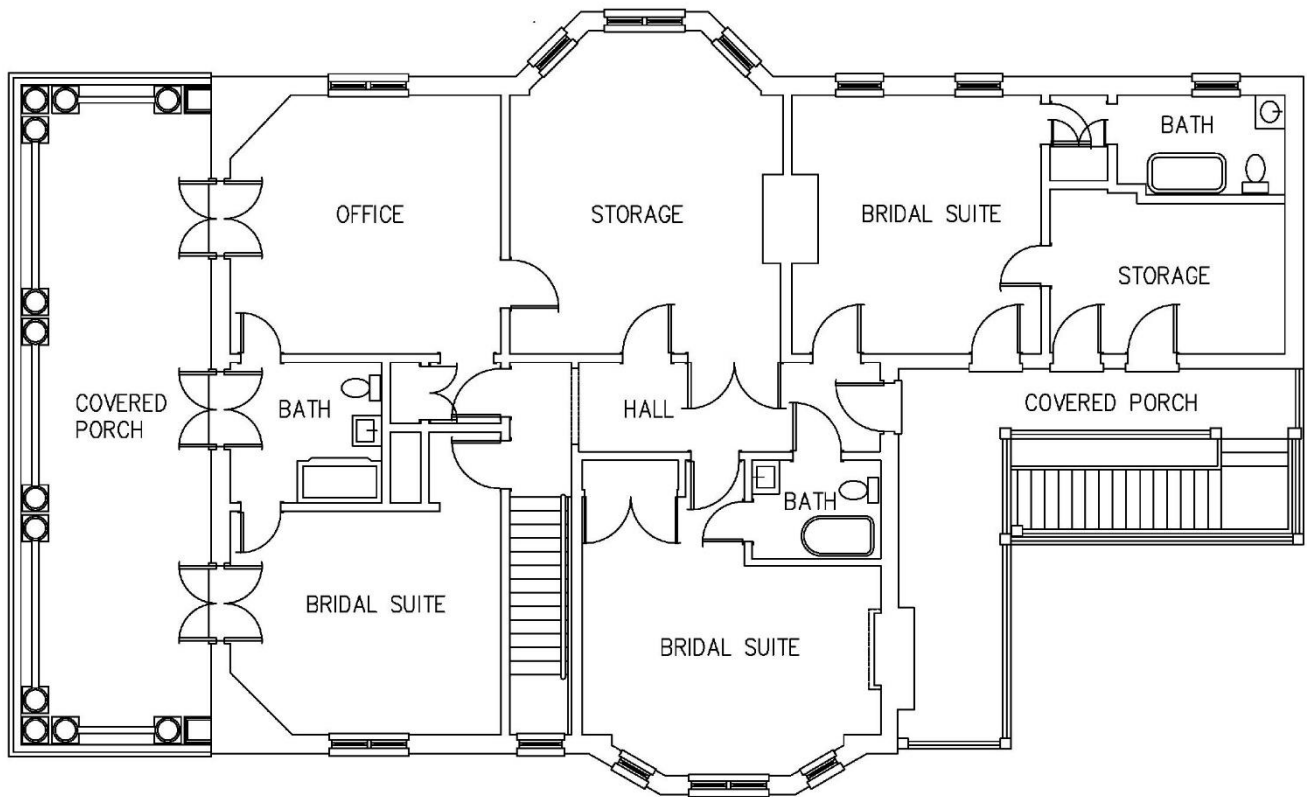

**Zoning District Correspondence Matrix**

- Directly Related
- Elements of the zoning category are related to the future LU category, but with qualifications (such as a development plan with conditions)
- Land use category is appropriate, but the district does not directly implement the category (e.g., open space in an industrial district)



## **MIXED COMMERCIAL CORRIDOR (MCC)**

This land use designation mostly applies to transportation corridors west of I-65 serving primarily the low-density (suburban) residential neighborhoods. MCC includes a wide variety of retail, services and entertainment uses.

This designation acknowledges existing commercial development that is spread along Mobile's transportation corridors in a conventional strip pattern or concentrated into shorter segments of a corridor.

Over time, new development and redevelopment in Mixed Commercial Corridors is encouraged to raise design quality, improve connectivity to surrounding neighborhoods; improved streetscapes; and improve mobility and accessibility for all users of the corridor.
